The South African Maritime Safety Authority (SAMSA) intends to appoint a qualified and experienced space planning service provider to redesign and optimise the existing office layout. The objective is to improve space utilisation, functionality, and overall workplace experience at the SAMSA Pretoria Office, 146 Lunnon Road, Hillcrest

Scope of Work

The appointed service provider will be required to:

1. Needs Analysis

- Conduct a detailed assessment of the current office layout.
- Engage with relevant stakeholders to understand operational requirements.

2. Space Planning & Design

- Develop space planning concepts aligned with organisational needs.
- Provide multiple layout options for consideration.
- Ensure optimal use of available space, including:
 - Workstations
 - Private offices
 - Meeting rooms
 - Storage solutions

3. Design Development

- Prepare detailed layout plans (2D and 3D where applicable).
- Recommend furniture layouts and configurations.
- Ensure designs comply with:
 - a) Occupational Health and Safety requirements
 - b) Building regulations

4. Technical Documentation

- Provide detailed drawings and specifications for implementation.
- Include electrical, lighting, and data point considerations where necessary.

5.1 Scope of Evacuation Plan Services

The service provider shall be responsible for the following:

- **Detailed Floor Plans:** Prepare evacuation drawings for all occupied areas of the SAMSA Pretoria Office.
- **Safety Indicators:** Clearly identify emergency exits, escape routes, assembly points, fire extinguishers, first aid stations, and emergency contact points.
- **Legibility:** Ensure plans are drawn to scale with a clear legend/key.
- **Format:** Produce plans suitable for framed display, printed and mounted in grey frames at designated locations.

5.2 Strategic Placement

Plans must be positioned at a height of approximately **1,500 mm from floor level** (centre of frame) at the following locations:

- Main entry and exit points.
- Adjacent to fire extinguishers and emergency equipment.
- Elevator lobbies and stairwell access points.
- High-traffic areas (reception, open-plan workspaces, corridors, and communal areas).
- Meeting rooms, boardrooms, and enclosed private offices.

5.3 Display Requirements: Grey Frame Specification

All plans must be displayed according to these specifications:

- **Frame Color:** Grey (RAL 7035 or equivalent institutional grey).
- **Material:** Aluminium or durable composite for wall mounting.
- **Glazing:** Shatter-resistant clear acrylic or safety glass.
- **Minimum Size:** A3 (420 × 297 mm); larger formats for larger floor areas.
- **Durability:** Laminated or printed on weatherproof stock.
- **Branding:** Must include the SAMSA logo, floor/zone identifier, and date of issue.

5.5 Deliverables
