2. SCOPE OF WORK

2.1 Background

The **National Radioactive Waste Disposal Institute (NRWDI)** is in the process of implementing a secure **Hybrid Active Directory (AD) Network** spanning three environments:

1. **Midrand (Head Office):** Administration Services
2. **Vaalputs (Operational Site):** Disposal Facility Operations
3. **Microsoft Azure Cloud:** Disaster Recovery (DR), Identity and Cloud File Backup

Core infrastructure has already been designed and partially procured. However, critical security licensing, management platforms and services are still outstanding, particularly for the FortiGate firewall environment that will secure connectivity between the three sites and the internet. NRWDI is implementing a hybrid Active Directory and cloud-enabled environment to ensure:

- Secure identity management
- Disaster recovery readiness
- Enterprise backup capability
- Secure connectivity between geographically separated sites

The NRWDI Hybrid AD architecture relies heavily on secure internet-based connectivity between Midrand, Vaalputs and Azure. The following critical components remain outstanding:

- i) Firewall security licensing
- ii) Centralized security management
- iii) Centralized logging & analytics
- iv) Secure remote access VPN
- v) Implementation and support services

These are mandatory to complete the deployment and secure the environment.

4. Evaluation Criteria

The evaluation will be carried out in three Phases:

- Phase 1: Mandatory Requirements (At Closing Stage)
- Phase2: Price and Specific Goals
- Phase 3: Mandatory Requirements (At Award Stage)

4.1 Mandatory Requirement (At RFQ Closing Date)

- i) A service provider who fails to quote fully or according to the price structure/table and scope of work will be disqualified.
- ii) Quotation submitted after the closing date and time will not be considered for evaluation.
- iii) Quotations that are not sent through the procurement central email will not be considered for evaluation.
- iv) Quotations that are not sent through the procurement central email will not be considered for evaluation.
- v) Submit a minimum of two reference letters from previous clients where a Fortinet licensing, support & maintenance was provided.
- vi) Submit a valid copy of Certified Fortinet Partner.
- vii) Service providers must be able to pay Fortinet first and provide proof of payment to NRWDI before payment can be made or provide credible assurance (such contract/accounts arrangement with Fortinet) that Fortinet will be paid and the service to NRWDI will not be affected/stopped because of non-payment to Fortinet.

4.2 Price and Specific Goals Evaluation

- I. The 80/20 preference point system will be applied to evaluate received quotations that complies with all mandatory requirements at the closing date and time of the RFQ in line with the Preferential Procurement Regulations, 2022.
- II. Price will be evaluated on 80 points and 20 points will be allocated to specific goals as illustrated on SBD 6.

4.3 Mandatory Requirements (at Award Stage)

- I. Non tax compliant Bidders will not be awarded the RFQ.
- II. Bidders listed in the Register of Restricted Suppliers or in the Tender Defaulters Register from National Treasury will be disqualified.

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

- 1.1 The following preference point systems are applicable to invitations to tender:
- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
 - the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).
- 1.2 The applicable preference point system for this tender is the **80/20** preference point system.
- 1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:
- (a) Price; and
 - (b) Specific Goals.
- 1.4 The maximum points for this tender are allocated as follows:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“black people”** is a generic term which means Africans, Coloureds and Indians—
- a) who are citizens of the Republic of South Africa by birth or descent; or
 - b) who became citizens of the Republic of South Africa by naturalisation—
 - i) before 27 April 1994; or
 - ii) on or after 27 April 1994 and who would have been entitled to acquire citizenship by naturalisation prior to that date;
- (b) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (c) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (d) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (e) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (f) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000); and
- (g) **“women”** means a person of female gender who is a citizen of the Republic of South Africa.

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
