Preferences are offered to tenderers who 8GB or Higher

Only tenderers who meet the following requirements will be eligible for this bid;

#### Administrative Requirements

Proof of Central Supplier Database (CSD) registration  
Completion of SBD 1, 4, 6.1 in full  
Copy of valid tax clearance with Tax Compliance Pin certificate (TCC)  
Proof of tender document purchase in the name of the bidding entity

#### Mandatory Requirements

Copy of Consolidated CSD for Joint Venture parties  
Proof of active CIDB registration - Grade 8 GB or higher  
Valid Letter of Good standing i.e COIDA Certificate from DOL / RMA / FEM  
Completion of Form of Offer in the tender document in full  
Completion of Bill of Quantities in full  
Copy of the Joint Venture Agreement signed by both parties (where applicable including apportionment of the JV (% share))  
As part of the Tender Conditions the bid shall be subjected to 30% Sub-contracting, tenderers must sub-contract a minimum of 30% of the value of the construction works (excl. VAT) to one of the following designated groups:

- oWomen
- oYouth
- oPeople with Disabilities
- oBlack People

Note: Should the bidder subcontract more than one bidder, the consolidated percentage must equate to 30% allocated for subcontracting. 30% subcontracting is a Condition of Tender. The bidders may select sub-contractors from the CIDB (if applicable to services being rendered) who are registered on CSD (Allocation breakdown of 30% sub-contracting to be completed on page 78 of the bid document)

Public Liability Insurance Cover/ Letter of Intent specific to the project (R20m or above)  
Attendance of the Compulsory Site Briefing Meeting and originally signed and stamped briefing certificate  
CV and Originally Certified Qualifications for Professionally Registered Project / Construction Manager (SACPCMP)  
CV and Originally Certified Qualifications for Professionally Registered Health and Safety Officer (SACPCMP)  
The contractor shall achieve in the performance of the contract the Contract Skills Development Goal (CSDG) established in the Standard for Developing Skills through Infrastructure Contracts (published in GN 48491 of 28 April 2023)

- Note: (i) Failure to submit any of the above documents / requirements shall result in immediate disqualification of the bid.  
(ii) Failure to complete and sign any designated spaces in the bid document shall result in immediate disqualification of the bid.  
(iii) If any of the Directors are listed on the Register of Defaulters, it shall result in the disqualification of the bid  
(iv) If any of the Directors are in the employment of the State, it shall result in the disqualification of the bid.

Only competent bidders who are competent in the advertised work and who have exceeded the minimum functionality threshold will be evaluated on a 90/10 (Price / Specific goals) points based on the Treasury Regulations of 2022, where functionality will be evaluated as follows:

Stage 1:

CriteriaPoints Allocation

Proof of experience in building projects (i.e. building works)35 points

Signed and stamped client reference 10 points

Qualified professional staff in the building engineering field (i.e CVs and Qualifications)15 points

Proof of plant ownership and/or plant lease agreement/ hire arrangements10 points

Financial viability 30 points

Total100 points

NB: Minimum qualifying threshold 70% (70 points)

Stage 2:

The 90/10 Preferential Point System will be applied, where 90 points will be allocated for price and 10 points for specific goals. In order to Claim and be awarded points bidders must evidence that they belong to the targeted group specified.

The IDT Quantity Surveyor (QS) may where necessary conduct a risk assessment on all bidders who obtained a minimum threshold of 70% (i.e 70 points) in the functionality stage before the application of 90/10 pricing criteria. Bidders are requested to price each line item of the Bills of Quantities (BOQ). Should the bidder be deemed too risky to complete the project based on the QS's risk assessment report, they will be eliminated and not be considered for 90/10 pricing points evaluation criteria in line.

Only bidders who obtain 70% (70 points) minimum functionality threshold will be evaluated further.

Specific goal points are allocated as follows:

Targeted GroupPoints Allocation

100% Women3

100% Youth3

100% People with Disabilities2

100% Black People2

Total Points10 are eligible to submit tenders.

A non-refundable tender deposit of R610.00 payable by proof of deposit is required on collection of the Tender documents.
