Critically evaluate cases involving medical negligence, malpractice, personal injury claims, and litigation processes.

Prepare clear, objective, and defensible medico-legal reports suitable for legal proceedings, insurance claims, and disciplinary hearings.
- Act as an expert witness
Demonstrate the ability to provide credible expert testimony in courts or tribunals, including report defence and cross-examination readiness.
- Apply principles of forensic and legal medicine
Integrate medical knowledge with legal requirements in areas such as injury assessment, disability evaluation, and causation.
- Identify and mitigate medico-legal risks
Recognise potential legal risks in clinical practice and implement risk management strategies to reduce liability.
- Improve medico-legal documentation and record-keeping
Maintain accurate, complete, and legally compliant patient records as critical evidence
