BACKGROUND

The Limpopo Department of Public Works Roads and Infrastructure (LDPWRI) is planning to train its employees as part of the broader Disability Access measures and in compliance to the implementation of the Provincial Sector Skills Plan, on South African Sign Language.

The officials have been trained on Basic sign language previously, however, due to lack of practice, may have forgotten some of the basics they had been taken through.

To that effect, The Department has taken a resolve to strengthen the already established base, by providing the same group of officials with an advanced course that will have them being able to communicate with deaf persons effectively. The Department is therefore looking to appoint accredited TSP's to provide training on, **"Hold conversations with Deaf individuals and groups of Deaf people on an unfamiliar topic using South African Sign Language"**.

All interested and relevant TSP's are invited to submit proposals and quotation as per below:-

Format of the training proposals should be as follows:

- Introduction and Background to the company or institution (*Please attach CSD document and Company Profile as Annexure 1 & 2*).

- Programme Outline and Methodology – what format will the training delivery take (blocks/ Lecture/assessments. (Please attach Programme outline per day)
- Assessment – will the learners be assessed and get a certificated of Competence.
- Costing – Unit cost and group cost including travel and accommodation where training will be delivered to learners and any other item that department will be costed on.
- Deliverables – What are the outcomes of the project?
- Aftercare/Value add – What additional uncosted benefits will the department derive out of utilizing the institution.
- Time Frames – Period over which the project will be implemented (**5 days**) –

aligned to the Programme outline above.

- Qualifications and CV's of facilitator/s – (Facilitators must be qualified in Advanced South African Sign Language and have a Facilitation certificate) - The submitted CV's must be the same facilitators that will be used during training and or in the event of replacements, a facilitator with equivalent Qualifications must be submitted to the Department prior the commencement of Training.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
