DESCRIPTION: SERVICING OF EMERGENCY VEHICLES AT THE PetroSA GTL REFINERY FIRE DEPARTMENT, MOSSEL BAY

1. INTRODUCTION

PetroSA seeks a service provider to perform inspections, servicing, and repairs to fire department trucks and emergency response vehicles on an as and when required basis. This includes assessing and maintaining all firefighting and emergency response systems integrated into the vehicles to ensure they remain fully operational and compliant with safety standards.

2. SCOPE OF SERVICES

The Supplier shall be required to perform the following, but not limited to:

a) Labour and supervision:

Supply of skilled personnel to carry out all inspections, servicing, replacement, and repairs.

b) Equipment and tools:

Provide the required equipment to successfully execute the service, including safety equipment and tools.

c) Materials:

Supply all the materials and consumables required to successfully execute the service.

d). Only original parts must be supplied.

3. SUPPLIER ADDITIONAL RESPONSIBILITIES

a) Check condition of the vehicles and note any parts that might need replacement.

b) All work must be completed in accordance with PetroSA's Vehicle Preventive Maintenance Procedures to ensure the safety, reliability, and readiness of the vehicles.

c) Tenderer is required to be accredited with International Organisation for Standardisation (ISO) 9001 or equivalent.

d) Tenderer must be the Original Equipment Manufacturer (OEM) or an authorised representative or agent.

e) Submit a Compliance Report after each scheduled service for each vehicle and report to indicate next required maintenance date.

The service will be conducted at the PetroSA GTL Refinery (onsite) – Mossel Bay, Western Cape.
