DTPC seeks to appoint suitably qualified professional service provider for the implementation of the following projects:

- TradeZone 3 - Bulk Earthworks & Infrastructure,
- Concrete Reservoir,
- Wetland Rehabilitation and
- Roads Upgrade

The above work will include project management element and related built environment specialist support for a period of three years.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.

The 20 preference points (Specific Goals) will be allocated to the following as included in the bid document:

- I. 10 points will be allocated to Enterprises (bidders) which are at least 51% Owned by Black People.
- II. 10 points will be allocated to Enterprises (bidders) who are located in KZN.

CPG Subcontracting Requirement

A minimum of 20% of work must be subcontracted to CPG Partners who are Exempted Micro Enterprises (EME) which are at least 51% owned by black people and located within KZN Province.
