DTPC hereby invites proposals for the **appointment of a contractor for the construction of AgriZone 1 flushline rising main from flush pond D to the holding pond.**

The work includes, but is not limited to, the following:

- Construction of a flushline rising main from flush pond D to the holding pond.
- Include necessary mechanical and electrical components such as pumps, valves, and air release mechanisms to ensure uninterrupted operation of the rising main.

It is estimated that tenderers must have an active **CIDB grading of 5CE or higher** by the closing date of the bid. **No Potential Emerging (PE) status is allowed.**

### **EVALUATION OF THIS BID**

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.

The 20 preference points will be allocated to the following as included in the bid document:

- 10 Points will be allocated to enterprises who are 51% Black Owned.
- 10 Points will be allocated to enterprises who are located in KwaZulu-Natal.
