1. PURPOSE

The objective is to find a suitable supplier to perform maintenance and servicing of the Eaton 9390, 120kVA UPS system, serial number 80000035 for a period of two years. This UPS is at the Postbank Freepen building, Zastron street, Westdene, Bloemfontein.

2. BACKGROUND

Postbank Operations in Bloemfontein are making use of a UPS to ensure business continuity which provides immediate back up power, bridging the gap until the generator is activated. The UPS also protects against any data losses including the servers in the IT server room. The UPS is a critical safeguard for Postbank operations, ensuring uninterrupted service delivery, data integrity, and compliance with financial regulations. Regular maintenance is essential to mitigate risks of downtime, protect customer trust, and extend equipment lifespan.

3. SCOPE OF WORK

3.1 UPS preventive maintenance on site

- Cleaning of UPS equipment
- Logging all measurements taken
- Checking mechanical soundness of all UPS components
- Simulation of operation and adjustments to electronic control circuits (if needed)
- Checking and adjustment of electronic supervisory and alarm circuits
- Control checks on all power devices.

3.2 Battery-specific tasks

- Checking mechanical soundness of all battery interconnections (and replacing faulty batteries if identified)
- Total float voltage measurement for battery strings
- Discharge test understanding load, recording total and individual battery voltage

3.3 Deliverables

- A detailed service report must be submitted within 5 working days after each quarterly service
- All work must be performed on-site after hours (to minimize business disruption)

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
