1. Service Providers must be registered on National Treasury's Central Supplier Database and submit a summary report as proof of registration or alternatively reflect the CSD supplier number on their proposal.
2. All prospective/interested Service Providers should complete the MBD 4, MBD 6.1, MBD 7.1, MBD 8, MBD 9 and Declaration of Bidder forms which are appended to the notice document.
3. Bidders must meet the minimum requirements stipulated in sections 7 and 8.
4. Bidders must meet the mandatory requirements stipulated in section 8 of the terms of reference.

TERMS OF REFERENCE: PROVISION OF SAFETY AND SECURITY SERVICES FOR A PERIOD OF 3 MONTHS

1. INTRODUCTION

BCMDA is calling for suitably qualified, experienced, and PSIRA-compliant security service providers for Provision of Safety and Security at Water World on a month-to-month basis up to 3 months.

2. SCOPE OF WORKS

The scope may include, but shall not be limited to:

- Provide static guarding services
- Provide access control services
- Conduct patrols
- Provide armed response and emergency support
- Asset protection
- Provide incident reporting and security administration

2.1 Static Guarding Services

3. SECURITY PERSONNEL REQUIREMENTS

5. CONTROL ROOM AND COMMUNICATION REQUIREMENTS

The successful service provider shall maintain:

- Incident escalation procedures
- Backup communication systems.

The control room must be capable of coordinating:

- Security personnel
- Emergency response
- Armed response teams
- Law enforcement support.

6. CONFIDENTIALITY AND INFORMATION SECURITY

Service providers shall:

- Maintain confidentiality
- Protect BCMDA information
- Comply with POPIA requirements

7. CONTRACT PERIOD.

The contract will be on a month-to-month basis up to three (3) months contract period. BCMDA reserves the right to terminate the contract at any time in the three (3) months period.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

CERTIFICATE OF INDEPENDENT BID DETERMINATION
