2. INTERPRETATION

2.1. APPLICATION

These Conditions of Bid govern the submission and adjudication of proposals and the acceptance by the Council of any proposal. They shall not form part of nor be interpreted or construed as forming part of any subsequent Contract as may result from the acceptance by the Council of any Bid received, nor shall these Conditions of Bid have any force or significance in any such subsequent Contract.

2.2. LANGUAGE

These Conditions of Bid shall be interpreted in the English language.

2.3. GOVERNING LAW

All Bids, as well as the adjudication thereof and the acceptance of any bid shall be subject to the law of the Republic of South Africa.

2.4. SINGULAR, PLURAL AND GENDER

In these Conditions of Bid, words importing the singular include the plural and words importing the masculine include the feminine and neuter and vice versa where the context requires.

2.5. HEADINGS AND SUB-TITLES

The clause headings and sub-titles in these Conditions of Bid shall not be deemed to be part thereof nor be taken into consideration in the interpretation or construction thereof or of the Conditions of Bid.

2.6. SCHEDULE AND FORMS TO BE COMPLETED BY THE BIDDER

2.6.1. Bidders must complete the proposal Documents where entries by the Bidder are required, in indelible black ink, and notice must be taken that tip-ex or any other corrective measures may not be used in the document.

2.6.2. All alterations must be initialled by the authorised submitter.



2.7. AMENDMENTS TO THE BID DOCUMENTS

2.7.1. AMENDMENTS BY THE BIDDER

- 2.7.1.1. Bidders shall not make any unauthorised amendment or addition to any part of the text or content of the proposal Documents. If any such unauthorised amendments, alterations or additions are made by the Bidder, these will be deemed to be of no force or significance in the Bid and will be ignored in the evaluation and adjudication of the Bid.
- 2.7.1.2. Any point of difficulty in the interpretation of the Bid Documents must be clarified with the Council as early as possible during the Bid Period. If a query by any Bidder is found to be of significance, the Council will inform all Bidders accordingly as soon as possible.

2.7.2. AMENDMENTS BY THE EMPLOYER

- 2.7.2.1. The Council shall be entitled, at any time prior to the Closing of Bids, to make any variation, amendment or addition to, or omission from the Bid Documents, including to the time and date set for the Closing of Bids, by the issuing of an Addendum (or Addenda).
- 2.7.2.2. Any Addendum so issued shall be deemed to form part of the Bid Documents and shall be communicated in writing to all parties who have acquired the Bid Documents from the Council.
Prospective Bidders shall comply in all respects with the content of any such Addendum and failure to do so will render any Bid subsequently submitted, as invalid.
- 2.7.2.3. No variation by the Council of the Bid Documents will be of any force or effect unless set out in an Addendum as described above, despite the fact that a variation of or amendment to the Bid Documents may have been implied in or may reasonably be inferred from any other document issued or statement made by the Council.

3. SIGNING OF BID

The Bid must be signed in the presence of the subscribing witnesses, by the person named in the form entitled "Authority of Signatory" in the section "Forms to be Completed by the Bidder" of the Bid Documents, as duly authorised by the Bidder to do so.

4. CONFIDENTIAL NATURE OF DOCUMENTS

The content of the Bid Documents is private and confidential and copyright in every aspect thereof remains vested in the Council. Recipients of the Bid Documents shall not be entitled to utilise the Bid Documents or any part of the content thereof for any purpose whatsoever, other than for the preparation and submission of their Bid and shall, whether a Bid is submitted or otherwise, treat the details of the documents as private and confidential.

5. COSTS INCURRED BY BIDDERS

The Council will neither be responsible for nor pay for any costs whatever, incurred by any Bidder or any recipient of the Bid Documents in preparing a Bid, nor in providing any such further information pertaining to the Bid as may be required by the Council or in terms of these Conditions of Bid.

6. ACCEPTANCE OF BID

The Council is not bound to accept any Bid or the lowest bid sum offered and reserves the right to award in part or in whole.

7. PERIOD OF VALIDITY OF BIDS

- 7.1. The bids shall remain valid for a period of three (3) months or 90 days after the Closing date.
- 7.2. Prices must be firm during this period and not linked to any exchange rate whatsoever.



8. REPUDIATION OF BID OR INVALIDATION OF CONTRACT

- 8.1. If the Council is satisfied that the Bidder or any person, whether an employee, partner, director, member or shareholder of the Bidder, or a person acting on behalf of or with the knowledge of the Bidder:
- 8.1.1. Has offered, promised or given a bribe or other gift or remuneration or reward to any person in connection with obtaining a contract; or has acted in a fraudulent or corrupt manner in obtaining a contract; or
 - 8.1.2. Has approached an officer or employee of the Council in order to influence the award of a contract in the Bidder's favour; or
 - 8.1.3. Has entered into an agreement or has made an arrangement, whether legally binding or not, with another person, firm or company to:

 - 8.1.3.2. as to the amount of the Bid to be submitted by either party;

Such address shall not be a postal box, private bag or electronic address, but shall be the address of a physical location within South Africa (e.g. street address, property/stand number or farm name etc.).

10. ADDITIONAL INFORMATION REQUIRED

- 10.1. The Council may request any Bidder to clarify any aspect of its Bid and also reserves the right to instruct a public accountant to report on the financial status of the Bidder, and the Bidder must render all reasonable assistance in such an investigation.
- 10.2. The additional information so obtained, as well as all written information submitted by the Bidder with and in support of its Bid, will be considered to form the basis on which the Bid has been prepared and submitted.

11. TAXES AND LEVIES

The bidder must submit with this bid an original and valid Tax Pin from the South African Revenue Services (SARS).

12. CLEARANCE FROM MUNICIPALITIES

The contractor must provide clearance from the municipality where they are based indicating that they are not in arrears with regard to their respective municipal services accounts. 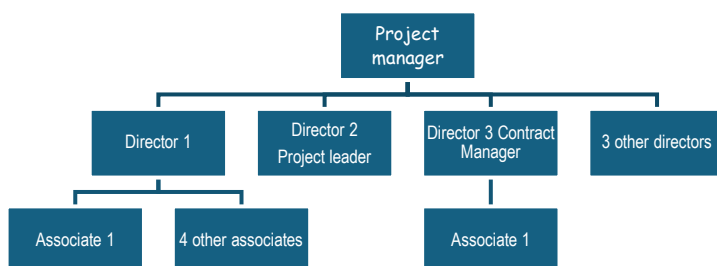

PART C2. SCOPE OF WORK AND BILLS OF QUANTITY

C2.1 SCOPE OF WORK

Monthly Reports and Operational Meetings

1. The service provider shall submit a comprehensive monthly report to the Municipality within 5 working days after month-end.
2. Reports must include: guard deployment schedules, attendance records, incident reports and resolutions, patrol logs, control room activity summaries, training sessions conducted and risk assessments.
3. The service provider shall attend monthly operational meetings convened by the Municipality. Attendance is compulsory for the Company Director or the Operations Manager or a delegated Senior official with decision-making authority.
4. Failure to submit reports or attend meetings will be treated as non-performance and subject to penalties.
5. Each monthly report submitted by the service provider must be accompanied by **copies of payslips for all appointed guards and supervisors.**

The below conditions must be adhered to by the appointed service provider with **no exception.**

Uniform and dress code

General Rules

1. All security personnel must be in full company-issued uniform while on duty, regardless of time of day or weather conditions.
2. Uniforms must be company branded with logo and guard identification.
3. Guards not in uniform will be treated as absent from duty for payment and performance purposes.

Specifications - Minimum gram per square meter (GSM Standards)

1. Shirts (Formal & Combat): Long-sleeved, collared, button-up, minimum two hundred grams per square metre (200 GSM) cotton/polyester blend.
2. Trousers (Formal): Minimum two hundred and fifty grams per square metre (250 GSM), tailored, dark colour.
3. Trousers (Combat): Minimum two hundred and fifty grams per square metre (250 GSM), reinforced stitching, rugged design.
4. Jersey/Sweater: Wool or acrylic blend, minimum three hundred grams per square metre (300 GSM), branded with company logo.
5. Jacket/Coat (Combat): Waterproof, insulated, branded winter jacket, minimum three hundred grams per square metre (300 GSM). No drimac jackets permitted.
6. Headgear: Company-issued cap (day/formal) or branded beanie (night/combat/winter).
7. Footwear (Formal): Genuine leather Parabellum shoes.
8. Footwear (Combat): Genuine leather SWAT boots with nylon mesh and rubber sole (standard SWAT boot construction). No safety boots permitted.



9. Prohibited Items: No golf shirts, T-shirts, sneakers, uniform resembling a Traffic uniform, uniform resembling a Police uniform, uniform resembling Military uniform or unbranded substitutes allowed.

Time and Location Requirements

Day Shift (07h00–19h00):

- a. Guards at municipal offices must wear formal uniform: shirt, trousers, Parabellum shoes, cap.
- b. Jerseys optional indoors depending on temperature; jackets not permitted inside offices unless approved.

Night Shift (19h00–07h00):

1. Guards at plants, workshops, and stations must wear combat uniform: shirt, trousers, SWAT boots, jersey, and jacket (cold weather).
2. Beanies permitted at night or in outdoor posts.
3. Cold Weather Areas (outdoor posts, plants, workshops, stations): Jersey and jacket compulsory.
4. Indoor Posts (offices): Shirt and trousers compulsory; jersey optional depending on temperature.

Verification of Uniform Material

1. The service provider shall submit manufacturer specifications and proof of procurement for all uniform items (shirts, trousers, jerseys, jackets, footwear) within 60 days of contract award.
2. The Municipality reserves the right to conduct physical inspections and GSM testing of uniform samples prior to deployment and during contract execution.
3. Guards found in non-compliant uniforms shall be treated as absent from duty and penalties will apply.



Penalty Clause

Vehicle requirement

1. All vehicles must be branded with the company name
2. All vehicles must be registered in Mpumalanga province
3. **No** vehicle may be fitted with either an intermittently flashing light or LED light including a dashboard light. Such includes any intermittently flashing light of any colour either that a light fitted by the manufacturer on the vehicle to any direction of the vehicle.
4. Only a white bar with the writing "**SECURITY**" or the name of the Company written in the centre will be allowed.
5. No vehicle may be fitted with a LED bar light to front or rear
6. No vehicle may be fitted with a siren system.



Risk Assessment and Deployment Requirements

1. The Municipality has conducted its own risk assessment and determined that the **deployment of security personnel and firearms is compulsory.**
2. Any company submitting a bid for this tender acknowledges and accepts that they shall deploy guards and firearms strictly in accordance with the **Bill of Quantities** provided.
3. The Municipality **will not enter into negotiations** regarding the risk assessments of individual service providers.
4. Should a company determine that a particular area is too risky for firearm deployment, that company retains the right to **terminate its contract with the Municipality.**
5. This clause is necessary to ensure consistency, compliance, and the safeguarding of municipal assets and operations. The Municipality is **not willing to compromise or negotiate** on this requirement.

Firearms:

1. The minimum calibre for Pistols will be a 9mm Parabellum
2. Pistols with a calibre of a 45 ACP or higher will not be allowed on any site
3. All Pistols shall be fully loaded at all times
4. No revolvers will be allowed.
5. All Pistols shall be **holstered and concealed** at all times.
6. Pistols manufactures more than 15 years ago are strictly prohibited.
7. All shotguns shall be in a semi-new condition
8. All weapons shall be serviced or cleaned on a regular base.
9. A company must be in possession of a SAPS issued firearm transport permit for the purpose of transporting firearms to and from the Municipality and sites.
10. Any Director, Supervisor or any other person representing the Company, if such a person is not in uniform, such a person shall not carry an unconcealed weapon in any premises of the Municipality.

Security lights on a vehicle:

Patrol Vehicle Lighting and Equipment Restrictions

1. **Prohibited Lighting and Sirens:** Patrol or monitoring vehicles may not be fitted with:
 - a. Intermittently flashing roof lights
 - b. Intermittently flashing dashboard lights
 - c. Intermittently flashing lights in the grill or bumper
 - d. Any siren
2. **Permitted Roof Light Bar:** Only a roof-mounted light bar emitting a diffused white light is permitted. This light bar must display either the word "**Security**" or the **name of the company** in its centre.



3. **Restriction on Additional Lights:** No other lights may be installed on patrol vehicles apart from factory-fitted lights. This restriction includes fog lights, spotlights, or any other non-standard lighting.

Guard equipment:

All guards must be in position of the following equipment

1. Two way radio or an instant communication device which should not be a Cell phone
2. Pepper spray
3. Baton
4. Torch
5. Pocket book
6. Pen
7. Firearms where specified

A security service is to be required in the form of the following security grades but not all grades will be applicable under this contract.

A	A security who could advise, report on matter affecting guarding, assist in the screening of candidates for employment, assume responsibility for staffing training draw money @ bank or similar institutions, guard/protect goods, drive a motor vehicle in the performance of any or all of the employees duties and is allowed/ supposed/ entitled to carry a fire - arm.
B	A security guard who might supervise, instruct or train security officer grade C and D report to the employer or any other specified person who may drive a motor vehicle in the performance of any or allowed/ supposed/ entitled to carry a firearm.
C	A security guard who could supervise / supervise security officer Grade D, drive a motor vehicle in the course of supervising or controlling security officer grade D and is allowed / supposed/ entitled to carry a fire – arm.

Additional compulsory requirements:

1. **PSIRA Compliance:** All guards must carry their valid PSIRA cards at all times while on duty.
2. **Firearm Handling:** All firearms must be holstered and managed strictly in accordance with the **Firearms Control Act, Act 60 of 2000.**
3. **Supervisor Armament:** Supervisors are required to be armed with both a pistol and a shotgun during duty. The shotgun must be equipped with a minimum of **15 rubber cartridges** and **12 live rounds.**
4. **Municipal Inspections – Firearms:** The Municipality reserves the right to inspect all firearms at any time.



5. **Municipal Inspections – Equipment:** The Municipality may inspect torches and communication devices at any time to ensure functionality.
6. **Shift and Uniform Compliance:** The Municipality will not remunerate any shift that is not fulfilled. A guard who is not in full uniform will be regarded as absent from duty, and the shift will not be paid.

Municipality's additional Rights and Conditions:

1. **Reallocation of Guards:** The Municipality reserves the right to transfer any guard from one site to another at its discretion, without prior consultation with the appointed service provider. Such transfers will be based on operational needs.
2. **Appointment of Multiple Service Providers:** The Municipality may appoint additional security companies at any time, for any purpose, even while an existing service provider's contract is in place. This may be done without prior engagement with current service providers.
3. **Reduction of Guard Scope:** The Municipality retains the right to reduce the number of guards allocated under the contract. Any such change will be communicated in writing, with a thirty-day notice period provided before implementation.
4. **Communication Devices:** As not all sites have charging facilities, it is the responsibility of the service provider's supervisors to ensure that all communication devices are fully charged and operational at all times.



Riot Team Requirements

1. **Composition and Command:** The Municipality requires a riot team consisting of fourteen (14) members under the leadership of one Commander.
2. **Member Qualifications and Equipment:** Each riot team member must:
 - a. Be qualified in crowd control.
 - b. Be in full uniform.
 - c. Be equipped with a hard hat.
 - d. Carry a 9mm pistol.
 - e. Carry a shotgun with rubber ammunition.
3. **Purpose and Deployment:** The team will be responsible for:
 - a. Protecting Municipal Offices and municipal assets.
 - b. Attending to incidents of community unrest when called upon.
 - c. Assisting during electricity cut-offs by accompanying an Electrician to households.
4. **Responsibilities During Electricity Cut-Offs:**
 - a. Where illegal electricity connections ("bridges") are identified, the Commander shall be responsible for opening criminal cases at the Police Station.
 - b. The Commander must remain available for any subsequent court proceedings.
 - c. Criminal cases shall be opened against both the household owner and any Electrician found to have made the illegal connection.
 - d. A thorough investigation must be conducted, including interviews with the household owner or occupant.
5. **Response Time:** The riot team must be on site within two hours of being called.
6. **Call Procedure:** A riot team may be requested telephonically, without the need for email or written confirmation. Such a call shall be deemed valid and authorized.

Special Patrols, Supervisor's Tasks, and Critical Infrastructure Team

1. **Municipal Challenges:** The Municipality faces ongoing threats to its critical infrastructure, with **cable theft** identified as a major concern. Experience has shown that such incidents may sometimes involve **collusion or negligence by guards and supervisors**, which makes strict oversight essential.
2. **Supervisor Responsibilities:** In addition to monitoring guards and shifts, Supervisors shall:
 - a. Conduct **special patrols** of all critical infrastructure, particularly during **night-time and early morning hours**.
 - b. Work in collaboration with the **Critical Infrastructure Team** on an ad hoc basis to address urgent risks.
 - c. Assist with **investigations** into incidents of theft, vandalism, or sabotage, including gathering evidence, interviewing suspects, and preparing reports for municipal authorities.
 - d. Ensure proper coordination and communication between patrol teams and municipal management.



- e. Actively monitor and prevent any **internal collusion** that could compromise municipal assets.

3. Critical Infrastructure Team Duties:

- a. Support Supervisors in safeguarding Municipal assets.
- b. Respond to incidents of cable theft, tampering or other infrastructure breaches.
- c. Provide rapid deployment capability when infrastructure is under threat.
- d. Work closely with law enforcement and Municipal officials where criminal activity is suspected.

4. Operational Requirements:

- a. Supervisors and team members must be **trained in infrastructure protection, crowd control and investigative procedures**. The company must be in possession of a South African Police Service issued National Key Point.
- b. All patrols must be **documented in daily logs**, submitted to the Municipality for review.
- c. Communication devices must remain fully operational during patrols.
- d. Patrols must be conducted in **uniform**, with appropriate protective equipment.
- e. Any evidence of **collusion or misconduct** by guards or supervisors will result in immediate disciplinary action, contract penalties or termination in line with MFMA provisions.

6. Intruder detection systems

The appointed company may be requested to undertake installations of intruder detection systems on a quotation basis. The company must hold SAIDSA accreditation or affiliation. The Municipality reserves the right to appoint any other company for this purpose.

ADDITIONAL SCOPE FOR RIOT TEAM

A bidding company must have an in-house armed response riot team. The riot team must have the following:

- The team must consist of fifteen members
- 1 Light delivery vehicle
- Transport for all team members
- All vehicles used by the riot team shall not have any intermittently flashing lights.
- Riot gear for all members
- A minimum of fifteen shot guns – Copies of certified licenses must be attached to this tender document.

Notes:

- A riot team will be expected to attend to any protest that may arise within the Municipality's area of jurisdiction. The team must be readily available for dispatch at any given time. The team will amongst other be tasked to deal with the protection of the Municipal assets including the road infrastructure against burning tyres, collecting evidence, arrest and lay charges against those found to be damaging Municipal assets.
- The Riot Team must respond within two hours to a call as and when they are needed



BEFORE THE COMPLETION OF THE BILL OF QUANTITIES, TENDERERS ARE ADVISED AS FOLLOWS:

Pricing and Payment Conditions

1. Bill of Quantities Structure

The Bill of Quantities has been designed so that tenderers must provide pricing for **Year 1, Year 2 and Year 3** of the contract.

2. Annual Escalations – PSIRA Illustrative Pricing Guide

Tenderers are required to anticipate annual increases in line with the **Private Security Industry Regulatory Authority (PSIRA) Illustrative Pricing Guide** and factor these adjustments into their pricing for Year 2 and Year 3.

The municipality will not be responsible for the incorrect alignment with the **Private Security Industry Regulatory Authority (PSIRA) Illustrative Pricing Guide in Year 2 and Year 3**, and there will not be any price adjustment on security guard's tendered rates.

3. Fuel Price Adjustment Clause

In addition, should the regulated fuel price, as published monthly by the **Department of Mineral Resources and Energy** increase or decrease by **15% or more** compared to the base month price at the time of appointment, the Municipality reserves the right to:

- 3.1. Renegotiate service levels, including the number of guards deployed to maintain affordability; or
- 3.2. Adjust contract rates proportionally to reflect the change.

The fuel price adjustment clause is applicable to items **70-72 of A. BILL OF QUANTITIES FOR SECURITY PERSONNEL.**

4. No Price Negotiations Post Appointment

Once appointed, the Municipality will not revise or negotiate any price increments, except for the fuel price adjustment clause. All tenderers have the opportunity to submit their rates for each contract year upfront, and those rates will be binding for the duration of the contract.

5. Responsibility for Rate Adjustments

It is the sole responsibility of the tenderer to ensure that rates are correctly adjusted for each contract year. If the tenderer fails to implement the correct escalation in Year 2 or Year 3, the Municipality will not be held liable for the error. The Municipality will not reimburse or pay any difference for the months affected by such an error.

6. Payslip Submission

The appointed service provider must submit a copy of each security officer's payslip to the Municipality on a monthly basis. Failure to comply will result in termination of the contract.

7. Invoice Processing

The Municipality will only process invoices after a completed inspection of all items in the scope of work and the Bill of Quantities. Failure to comply with all requirements will result in non-payment of the invoice.

8. Deployment of security guards

The municipality reserves the right to deploy security guards on an **"as and when required basis"**. Should there be a need to reduce guards at specific sites, a notice will be provided to the bidder two (2) calendar months prior to the termination. The municipality may redeploy existing guards to any site belonging to the municipality.
