- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

Note: For the purpose of obtaining evidence to be submitted by bidders for all RFQ and Tenders, it must be noted that the percentage for points allocation for woman, youth, black people and disability will be calculated based on the CIPC and CSD Detailed Summary Reports. Therefore, all bidders will be required by the fund to submit all the necessary documents in order to comply with the bidding requirements.

Furthermore, bidders are required to furnish the fund with the supporting proof from a medical doctor or any institution that are certified to prove disability in order to ensure that bidders obtains maximum points. Failure to submit authentic evidence will lead to disqualification, further investigation and possible contravention with the Prevention and Combating of Corrupt Activities Act; the Criminal Procedure Act (section 269A theft; fraud; extortion); the Public Administration Management Act.
