The appointed contractor shall provide all labour, supervision, transport vehicles, packing materials, lifting equipment, insurance, project management, and specialist resources required to relocate NRWDI assets from Pelindaba to Midrand.

2.2 Project Planning and Management

The successful bidder shall:

- Coordinate relocation activities with NRWDI.
- Allocate an experienced relocation project leader.
- Provide relocation schedules and progress updates.
- Ensure completion within agreed project timelines.

2.7 Insurance Requirements

The successful bidder shall maintain comprehensive insurance for the entire relocation period. The minimum insurance cover shall include:

- Goods-in-Transit Insurance;
- Public Liability Insurance;

The insurance shall adequately cover the replacement value of all NRWDI assets being transported from Pelindaba to Midrand.

Proof of insurance shall be submitted before commencement of the relocation.

3. EVALUATION CRITERIA

The evaluation will be carried out in three Phases:

- Phase 1: Mandatory Requirements (At Closing Stage)
- Phase2: Price and Specific Goals
- Phase 3: Mandatory Requirements (At Award Stage)

3.1 Mandatory Requirement (At RFQ Closing Date)

- Service providers who fail to quote fully or according to the price structure/table and scope of work will be disqualified.
- Quotation submitted after the closing date and time will not be considered for evaluation.
- Quotations that are not sent through the procurement central email will not be considered for evaluation.
- Submit a minimum of three reference letters (the letters must not be linked or conflicted with the bidding company) from previous clients where offices were relocated. The letters must be under the letter heads of previous clients, have contact person & contact details and be signed.
- Submit ID copies of the owners/directors of the bidding company as reflected on official registration documents e.g CIPC, CSD Report or BBBEE Certificate / Affidavit.

3.2 Price and Specific Goals Evaluation

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“black people”** is a generic term which means Africans, Coloureds and Indians—

- (e) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
