

Delivery Requirements: (Door to Door)

TSSSA Training Team is responsible for maintenance training of the EMU Trains nationally between below mentioned regions. For the training schedule to run effectively it is important for us to have a contract with a courier service in place to be able to deliver training material to various regions on an as and when basis. The last contract expired 31 March 2026

- Goods to be delivered within 24 hours (overnight) to the Instructed address (Training center per region)
- Deliveries will be in:
 - **Western Cape**
 - TSSSA Computer Centre / Admin office Ryan Road, Rosebank, Cape town, 7700
 - Paarden Eiland Rolling Stock Depot - Sunnyside Crescent, Off Voortrekker Road, Western Cape 7925
 - **KwaZulu Natal** - Prasa Lifting Workshop, off Masabala Yengwa Ave, Durban 4001
 - **Gauteng** – TSSSA Training Centre, Koedoespoort Road & cnr. Of Lynette Street, Pretoria
- Goods will be collected at TSSSA training center Koedoespoort Pretoria to be delivered to designated address.
- Delivery notes will be signed by the receiver of the goods and by the delivery person – this will be sent to the TSSSA training center Koedoespoort.

Goods requirements (parcels)

- All goods will be packed in boxes and sealed at Training centers
- The designated address will be secured to the parcel box, including the receiver's contact details

What must be done by the Courier service:

- Provide a unit price (vat inclusive) per 5 kilogram and 10 kilograms for delivery in the regions. (Refer to Rates table as an example).
