1. PURPOSE

The purpose of this request is to appoint a service provider for the replacement of cupboards and carpentry works in the Tsitsikamma Section of Garden Route National Park for a period of 24 months.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

3. SCOPE OF WORK

The contractor shall:

- Verify all site measurements before fabrication
- Manufacture, supply, deliver and install kitchen cupboards
- Supply and install countertops (Granite or Formica option)
- Install all hardware and accessories
- Ensure proper levelling, alignment and secure fixing
- Seal all joints and exposed edges
- Remove rubble and leave the site clean

Colour of cupboards and countertops will be confirmed with the successful bidder prior to manufacture.

2. TECHNICAL SPECIFICATION

2.1 Carcass Construction

- 18mm white melamine board
- Moisture-resistant board for sink units
- All exposed edges sealed
- All joints glued and mechanically fixed
- Units to be rigid, square and structurally sound

2.2 Doors & Drawer Fronts

- 18mm melamine
- Colour to be confirmed with successful bidder
- Smooth finish free of defects
- All exposed edges fitted with 2mm impact-resistant PVC edging

2.3 Durable Edging (Mandatory)

- 2mm PVC edging on all exposed edges

- Machine applied (iron-on edging not permitted)
- Heat sealed and moisture resistant
- Suitable for high-traffic kitchen use

2.4 Hardware

- Soft-close concealed hinges
- Heavy-duty drawer runners (minimum 35kg load rating)
- Adjustable legs
- Stainless steel handles
- Corrosion-resistant screws and fixings

2.5 Countertops

Granite Option

- 20mm or 30mm polished granite
- All edges polished
- Sink and hob cut-outs included
- Sealed against moisture penetration

Formica (High Pressure Laminate) Option

- 32mm postform laminated countertop
- High-pressure laminate finish
- Moisture-resistant backing board
- 2mm PVC sealed edges

2.6 Installation

- Units to be level, plumb and securely fixed
- All wall and sink joints sealed with silicone
- No visible gaps between units
- All exposed screws capped
- Surfaces protected during installation

2.7 Warranty

- Minimum 12-month workmanship warranty
- All materials must be new and free from defects

NOTE: Failure to submit all mandatory documents will result in disqualification of bids.

7. Evaluation Phase: FUNCTIONALITY

This bid will be evaluated using a 2 phased system where Phase 1 will be Functionality and Phase 2 Price and B-BBEE. Bidders who fail to meet the minimum qualifying score 65% will not be evaluated further for Price and B-BBEE. The 80/20 Preference Points system as prescribed by the Preferential Procurement Regulations, 2022 will be used in Phase 2. Points on phase 1 will be allocated as follows:

- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
