- A submission submitted in response to this RFB will constitute a binding offer which will remain binding and irrevocable for a period of **one hundred and twenty (120) days** from the date of submission to the MHSC. Bidders may not modify their initial pricing offer whilst the RFB validity period is still in force. **(RFB Validity Period: 120 days from date of closure)**
- No service will be rendered, or goods delivered before an official MHSC Purchase Order has been issued to the awarded bidder.
- It is the responsibility of the bidder to ensure that its response reaches MHSC on or before the closing date and time of the RFB.

INTRODUCTION TO MHSC

The Mine Health and Safety Council (MHSC) is a national public entity (Schedule 3A) established in terms of the Mine Health and Safety Act, No. 29 of 1996, as amended. The MHSC is mandated to advise the Minister of the Department of Mineral and Petroleum Resources (DMPR) on mine health and safety (MHS) issues in the mining industry, relating to the development and implementation of the MHSC annual MHS research programme, reviewing and development of MHS legislation and dissemination (knowledge and technology transfer) of MHSC research outcomes to improve MHS conditions in the South African Mining Industry (SAMI).

Occupational Noise-Induced Hearing Loss (ONIHL) is defined as a partial or complete hearing loss in one or both ears resulting from exposure to occupational noise. ONIHL typically develops gradually over several years due to continuous or intermittent noise exposure (Mirza et al., 2018, as cited in Chen et al., 2020). Despite being largely preventable, ONIHL remains a significant occupational health concern in South Africa (Naicker, 2004). More recent reports indicate that ONIHL continues to rank among the top three reported occupational diseases in South Africa (Department of Employment and Labour [DEL], 2020) and among the top two reported occupational diseases in the South African Mining Industry (SAMI).

In the mining industry, noise exposure is prevalent due to the operation of heavy machinery, drilling and rock-breaking activities, rock sorting and milling, and the confined underground environment (Chamber of Mines Annual Review, 2017). These work activities place miners at risk of developing ONIHL.

By 2024, the SAMI employed over 450 000 employees. Approximately 80% of employees in SAMI are exposed to occupational noise at/above 85dB(A), placing them at risk of developing ONIHL. In SAMI, 705 cases of NIHL were reported in 2024, with the highest prevalence in the Platinum sector (MHSC, 2024/2025). Employees in the SAMI are also exposed to non-occupational noise emanating from sources such as construction, traffic, recreational and social activities.

A hearing conservation programme (HCP) is a comprehensive approach aimed at preventing NIHL from both impulse and continuous noise exposure through measures such as engineering controls, worker training, demarcation of noise zones, audiometric testing, and the consistent use of hearing protection devices (HPDs) (DoL, 2003b). Although engineering controls are the preferred method for reducing hazardous noise, they are often impractical or cost-prohibitive, necessitating the use of HPDs as a supplementary control (Hong et al., 2005).

However, the effectiveness of HPDs is frequently compromised by improper and inconsistent use, which is influenced by factors such as individual health beliefs, perceived risk, comfort, and perceived benefits. Additionally, modifying factors (e.g., gender and noise levels), situational factors (e.g., union climate), and cognitive-perceptual factors (e.g., perceived barriers and benefits) significantly influence HPD usage among African workers (Reddy et al., 2012).

Early identification of hearing loss and the effective implementation of Hearing Conservation Programs (HCPs) are critical to mitigating the impact of ONIHL and ensuring the health and safety of workers in high-risk environments. While HCPs are widely implemented within the SAMI, their effectiveness in practice remains uncertain, particularly in relation to implementation, compliance, and long-term outcomes. In addition, the contribution of non-occupational noise exposure to overall hearing loss risk is often not adequately considered. This project therefore seeks to evaluate the effectiveness of current HCPs in SAMI and investigate the inclusion of non-occupational noise exposure in understanding and managing hearing loss risk.

CONTEXT OF PROCUREMENT

The MHSC seeks to appoint a service provider to evaluate the effectiveness of current HCPs in SAMI and identify opportunities for improvement.

South African National Parks (MHSC) cannot amend the National Treasury’s General Conditions of Contract (GCC). MHSC appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.

The contracted party shall procure where necessary the signatures of its personnel for the assignment of the contract intellectual property to MHSC, or as MHSC may direct, and to support MHSC, or its nominee, in the prosecution and enforcement thereof in any country in the world. The contracted supplier hereby irrevocably appoints MHSC to be its true and lawful agent in its own name, to do such acts, deeds, and things and to execute deeds, documents, and forms that MHSC, in its absolute discretion, requires in order to give effect to the terms of this clause.
