Increase in prices for Year 2 and year 3 will be based on CPI. After careful consideration, the department has noted that for textile manufacturing sector, PPI is used instead of CPI (Producer Price Index) to allow average changes in selling prices. ECDOH has amended the condition to read as follows: •Prices shall be firm for the first 12 months. Increase in prices for Year 2 and year 3 will be based on PPI (Producer Price Index) 2.On Page 18, paragraph 26 of the bid document, it has been stated that:- a. Where a standard is indicated, a sample must be submitted to a testing institution accredited or recognized by SANAS before or on the closing date and time of the bid. The purpose is to obtain a test report for the items being offered in the bid. b. The procedures for sampling and testing for product compliance may differ and should be obtained from the relevant testing institution. The cost of compliance testing will be for the account of the prospective bidder. c. Test reports must be submitted with the bid at closing time and date of bid proving that the relevant items comply with the standard after inspection and testing of the samples by a SANAS accredited or recognized institution. The Test reports must not be older than twelve (12) months at the closing date of the bid. In the event that a test report cannot be obtained from the testing institution prior to the closing date and time of the bid, the bidder must obtain proof (issued by the testing institution) that the samples had been submitted to the testing institution for testing before or on the closing date and time of the bid. Such proof must be submitted with the bid at closing date and time of the bid. In this case, the actual test reports must be submitted to the Department of Health, Supply Chain Management, Strategic Sourcing and Bid Management Unit within a period of 15 (fifteen) calendar days from the closing date of the bid. e. Failure to comply with this condition will invalidate the bid in respect of the item for which a test report is not submitted. After noting the requirements for test reports, the department came to a decision to remove the paragraph and will rely on the testing as well as verification by the Department of Health. 3. On Page 19, Paragraph 28: PRE-PRODUCTION SAMPLE, a requirement has been added as:- 28.8. Shortlisted bidders are to engage SANAS accredited inspection body to evaluate the pre-production samples and produce a test report.
