All prospective qualifying service providers are hereby invited to submit their proposals for a review of the Annual Financial Statements (AFS) with Applicable Laws and Regulations for the 2025/2026 financial year.

The service provider must possess the following:

- The team leader of the project must be a qualified CA(SA) in good standing with SAICA / Certified Internal Auditor (CIA) and registered with the relevant Professional Body (Preferable Institute of Internal Auditors-IIA).
- Each team member must have a minimum of a Bachelor's degree of Commerce in Accounting, Auditing/ Finance, or equivalent, coupled with a minimum of three years of practical experience.
- The service provider must possess proven experience and knowledge of the preparation and reviewing of Generally Recognized Accounting Practice (GRAP) compliant Annual Financial Statements (AFS) of a municipality.
- The service provider must possess proven experience and knowledge of reviewing Compliance of the municipality with applicable Laws and Regulations.
- Knowledge of applicable legislation and regulations is compulsory, including the Municipal Systems Act, the Municipal Structures Act, Municipal Finance Management Act (MFMA), MFMA Circulars, Treasury Regulations relating to Municipalities, GRAP, MSCOA Circulars, etc.

2. Issues identified and raised by the Internal Audit Unit of review of Interim Financial Statements (9 Months) for the 2025-26 financial year are followed up to determine whether those issues were addressed by the management.

3. Comparative figures in the AFS agrees to prior year audited AFS including accounting adjustment required.
4. The AFS are correctly cast and cross-casted.
5. The notes to the AFS are properly numbered and correctly linked to the AFS.
6. Figures presented in the face of the statement of financial performance and financial position to the disclosure notes all have supporting schedules or working paper files;
7. The notes to the AFS support the balances in the Statement of Financial Performance, Statement of Financial Position and Cash Flow Statements.
8. Information contained in the audit file is sufficient and adequate to support the AFS i.e. working paper files/ schedules/ registers/ lists (accounting file) for validity, accuracy and completeness to ensure that they are GRAP compliant and in accordance with MFMA Circular 50;
9. Review overall compliance of the AFS to Generally Recognised Accounting Practice (GRAP) and the MFMA against the National Treasury Regulations and Specimen Financial Statements;
10. The completeness of the draft AFS, that all the financial information is recorded.
11. The AFS agrees to the fixed asset register, debtors age analysis and other required supporting documentation contained in the audit file.
12. Obtain trial balances and determine whether it is aligned to the general ledger and the financial statements.
13. Accounting policies and policies are in place, comply with GRAP standards and are applied appropriately.
