5. Validity Period

Responses to this Request for proposal received from Bidders will be valid for a period of **150 days**, calculated from the closing date.

6. Submission of Response

- 6.1 Only properly filled and fully signed documents in line with the RFP requirements must be submitted on PDF format via email to tenders@nefcorp.co.za by no later than 14h00 on 19 August 2026. No proposals will be accepted after cut-off date and time.
- 6.2 No bids received by telegram, telex, facsimile, hand-delivery, post or any medium other than the above prescribed method will be considered.
- 6.3 Where an RFP document is not received at the time of the RFP closing, such an RFP document will be regarded as a late bid. Late bids will not be considered.
- 6.4 The Bidder is responsible for all the costs that shall be incurred in relation to the preparation and submission of the bid document.
- 6.5 A list of all references (minimum 2) with contact details must be included in the RFP document.
- 6.6 Copies of qualifications, identity documents (IDs) and the curricula vitae (CVs) of persons who will be involved in the execution of this bid should the bidder be successful must be attached to the proposal.
- 6.7 The following information also needs to be provided with the bid document:
- Names and details of senior management
 - Employment equity details of employees at an operational level
 - Percentage of ownership by number of:
 - Black ownership
 - Black women ownership
 - Youth ownership
- 6.8 A valid Tax Status Pin document must be included in the bid document. Failure to submit would render the bid invalid.
- 6.9 Bidders are advised to submit / send their bid responses at least 15 minutes before the deadline

to avoid any Information Technology (IT) network congestion or technical challenges in this regard which may result in bid responses being received late. NEF's e-mail servers are configured to receive e-mails with sizes up to 18MB.

6.10 The NEF will not be held responsible for any of the following:

- bid responses sent to the incorrect email address;
bid responses being inaccessible due to non-standard electronic file formats being utilised to submit responses by bidders;
- any security breaches and unlawful interception of tender / bid responses by third parties outside the NEF's IT network domain;
- bid responses received late due to any IT network related congestion and/or technical challenges; and bid responses with file size limits greater than NEF's e-mail receipt capacity of **18MB**.

6.11 Copies of any affiliations that the bidder may have must be attached to the response to this bid.

6.12 Kindly note that the NEF is entitled to amend any RFP conditions, validity period, specifications, or extend the closing date of bids before the closing date. All Bidders, to whom the RFP documents have been issued, will be advised in writing of such amendments within reasonable time after they are made.

6.13 The NEF reserves the right not to accept the lowest bid or any bid in part or in whole.

6.14 The NEF also reserves the right to award this bid to any party whom it decides as a whole or in part without furnishing reasons. The NEF reserves the right to withdraw this RFP at any stage with or without giving reasons.

6.15 The Bidders hereby offers to render all or any of the services described in this RFP document to the NEF on terms and conditions and in accordance with the specifications stipulated in this RFP document. This RFP document and the bidder's response thereto shall form part of any service level agreement that may be concluded between the NEF and the bidder. In the event of conflict between such documents, the service level agreement shall take precedence over all other documents.

6.16 Bids submitted by juristic persons or partnerships must be signed by a person or persons duly authorized thereto by a resolution of a board of such juristic person, a copy of which resolution, duly certified be submitted with the bid.

6.17 The Bidders shall prepare for a possible presentation should NEF require such and the Bidders shall be notified thereof no later than 4 (four) days before the actual presentation date.

7. CONDITIONS AND UNDERTAKINGS BY BIDDERS IN RESPECT OF THIS RFP

The Bidders hereby agree that the offer herein shall remain binding upon him/her and will be open for acceptance by the NEF during the validity period indicated herein.

TERMS OF REFERENCE / SCOPE OF SERVICE

- **Preamble**

The National Empowerment Fund (NEF), established by the National Empowerment Fund Act No. 105 of 1998, promotes and facilitates economic equality and Broad Based Black Economic Empowerment by providing development finance to Black-empowered South African businesses. As an agency of the Department of Trade, Industry and Competition (**the dtic**), the NEF is mandated to advance Broad-Based Black Economic Empowerment (B-BBEE) through innovative financing, investment products, and support for inclusive growth.

To advance its strategic objectives, the NEF has established the ESD & Third-Party Fund and Treasury, a catalytic blended financing vehicle designed to accelerate economic transformation, crowd-in public and private sector capital, broaden access to capital for Black-owned businesses, and unlock inclusive growth opportunities. The fundraising panel is envisaged as a strategic financing platform that will mobilize developmental, commercial, and impact capital to support inclusive industrialization, enterprise development, localisation, job creation, and economic participation. To achieve this, the NEF requires the services of a panel of fundraisers with proven expertise in fund structuring, Development capital raising, to support its fundraising activities.

- **Background**

The NEF mandate aligns with the country's growth and development strategy of the South African Government since the dawn of democracy. In January 2004, the Broad-Based Black Economic Act 53 of 2003 ("B-BBEE Act") was passed into law and has been in operation for the last 20 years. However, a significant portion of the population, primarily Black people (African, Coloured, and Indian), remain excluded from full participation in the mainstream economy despite the progress achieved through democratic reforms and the implementation of policies such as the B-BBEE Act. By focusing on enhancing economic participation, access to opportunities, and income-earning potential, the government seeks to empower these communities, enabling them to contribute more effectively to the country's economic growth. This approach is central to building a more inclusive and equitable society, where economic opportunities are more widely distributed, and social disparities are progressively addressed.

To realise its strategic objectives, the NEF is implementing a comprehensive resource mobilisation and capitalisation strategy. A critical component of this strategy is the establishment of a panel of fundraisers, who will bring specialised expertise in donor engagement, capital raising, and partnership development. The purpose of the panel of fundraisers is to provide specialised strategic, technical, and support to the NEF in mobilizing financial and non-financial resources for the NEF. Panel members will support positioning and partnership opportunities aligned with the National Empowerment Fund mandate.

- **Scope of Work**

Panel members may be contracted to provide services across one or more of the following areas:

- Support the Fund's resource mobilisation and capitalisation strategy.
- Identify and pursue targeted opportunities for funding from diverse sources
- Advise on innovative financing instruments and partnership models that can unlock capital
- Donor Prospecting & Intelligence gathering: Map potential funders aligned with the Fund's mission.
- Proposal Development: Co-create investment and funding proposals tailored to donor/investor requirements.
- Capital Raising: Lead or support investor engagement processes, fundraising campaigns, roadshows and negotiations.
- Stakeholder Engagement: Facilitate strategic engagements with philanthropic foundations, bilateral and multilateral donors, DFIs, corporates, and impact investors.
- Fund mobilisation: Advise on blended finance structures and innovative financing instruments.

- **Composition and Selection Criteria**

The Panel will comprise of fundraising professionals, firms, or consortia selected based on:

- Demonstrated (proven with references) track record in fundraising for development or impact investment funds.
- Knowledge of donor/investor landscape.
- Experience with blended finance, ESG, and impact capital models.
- Strong networks with philanthropic, public, and private funding sources.
- Proven ability to develop bankable proposals and negotiate funding agreements.

- Understanding of PFMA, governance, compliance, and donor due diligence requirements.
- Experience working within emerging markets and or development finance ecosystems.

- **Duration of the Panel**

The Panel will be established for a period of three (3) years renewable based on performance and the evolving needs of the NEF. Panel members may be engaged on a call-down basis, as and when specific assignments arise, however payments will be honored on a raising fee basis only.

- **Deliverables**

The deliverables will be defined in assignment-specific Terms of Engagement but may include:

- **Donor/Funder Mapping Reports:**

Comprehensive analysis and segmentation of potential funding sources including philanthropic foundations, bilateral/multilateral agencies, DFIs, corporates, and high-net-worth individuals (HNWIs). Reports should highlight alignment with the Fund's mandate, funding windows, key contacts, funding cycles, and engagement strategies.

- **Investment Proposals and Pitch Decks:**

High-quality, investor-ready documents tailored to specific funders and investor profiles. This includes value proposition, impact theses, risk-return narratives, use-of-funds breakdowns, and alignment with ESG and SDG frameworks. proposals should be compelling, data-informed, and visually engaging to support successful fundraising pitches.

- **Memoranda of Understanding (MoUs), Agreements, and/or Letters of Intent (LoIs):**

Drafting and facilitation of preliminary or formal agreements with funders and strategic partners. These documents should outline commitments, areas of collaboration, funding mechanisms, and mutual expectations, thereby formalising intent and paving the way for capital disbursement or co-financing arrangements.

- **Stakeholder Engagement Plans and Reports:**

Detailed strategies for engaging and stewarding current and prospective donors/investors. This includes stakeholder mapping, communications calendars, relationship management protocols, and contact logs. Post-engagement reports should capture outcomes, lessons learned, and follow-up actions.

- **Capital Mobilisation Tracking Tools and Dashboards:**

- Design and implementation of monitoring tools and real-time dashboards that track fundraising pipelines, commitments secured, disbursement timelines, and partner engagement progress. These should be structured to support performance management, decision-making, and reporting to governance structures and fund stakeholders.
- Co-financing arrangements, guarantee mechanisms, catalytic capital frameworks, and other innovative financing models aimed at enhancing the Fund's ability to crowd-in commercial and developmental capital.

6. Remuneration

Compensation will align strictly with globally recognized financial market benchmarking such as:

- **Success Fee:**

A success-based incentive fee will be payable upon securing firm commitments¹ for the NEF. This fee will be structured as a pre-determined percentage of the total capital raised and will be paid following the receipt of signed agreements or actual disbursements, as defined in the assignment-specific Terms of Engagement with the following pricing consideration;

- 2,5% of the total capital raised
- The NEF reserves the right to pay an additional bonus of up to 0,5% of total funds raised at its sole discretion based on exceptional performance eg. mega transactions, turnaround times, innovative structures.
- The total Success Fee will be capped at 3%, including any bonus as may be applicable.

- **Deliverable Based Fees:**

For specific technical outputs, (panel members may be remunerated on a per-deliverable basis, in line with pre-approved budgets and milestones.

¹ Firm Commitment refer to funds that are readily available for NEF to draw down, and all condition precedence have been met.

- **Experience required**

Panel members must demonstrate a strong track record of success in resource mobilisation and fundraising within the development, impact investment, or philanthropic sectors. The following areas of expertise will be considered essential:

- **Fundraising Strategy and Execution**

- Proven experience in developing and implementing resource mobilisation strategies for development funds, impact enterprises, or multi-stakeholder financing platforms.
- Strong understanding of capital raising approaches across grant, concessional, and commercial capital.

- **Donor and Investor Engagement**

- Demonstrated ability to identify, engage, and sustain relationships with a diverse range of funders, including:
 - Philanthropic foundations
 - Bilateral and multilateral donors
 - Development finance institutions (DFIs)
 - Corporate social investment (CSI) arms
 - Private sector investors and HNWIs
 - Familiarity with donor preferences, decision-making cycles, and reporting standards.

Proposal

Expertise in designing investment-ready proposals, pitch decks, and term sheets tailored to different funding audiences.

- Sector-Specific Knowledge (Highly Advantageous)
- Knowledge of the NEFs mandate and inclusive growth agenda, particularly in the context of:
 - i. Small, medium, and micro enterprises (SMMEs)
 - ii. Gender-lens or youth-focused investment
 - iii. Climate finance or green economy initiatives
 - iv. Enterprise development in South Africa or similar emerging markets
 - v. Geopolitical awareness

- **Networking and Advocacy Skills**
- Strong networks within relevant funding ecosystems, and an ability to open doors to new partnerships.
- Excellent negotiation, communication, and relationship management capabilities.
- **Compliance and Governance Familiarity**

Understanding of donor compliance requirements, and funding governance protocols.

Privacy & Protection of Personal Information Act 4 of 2013 Requirements

Name of Bidder:	

Protecting personal information is important to the National Empowerment Fund (NEF). To do so, NEF follows general principles in accordance with applicable privacy laws and the Protection of Personal Information Act 4 of 2013 (POPIA).

NEF's role as a responsible party is amongst others to process personal information for the intended purpose for which it was obtained and in line with legal agreements with its respective/prospective clients, third parties, suppliers, and operators.

Who is an Operator? A person or body/ entity which processes personal information for the NEF in terms of a contract or mandate.

Who is a Supplier? A natural or juristic person that provides a product or renders a service to the NEF. A supplier could also be considered as an operator, an independent responsible party or (together with NEF) a joint responsible party.

If the supplier or business partner provides NEF with its related persons' personal information, the supplier or business partner warrants that the related persons are aware of and have consented to the sharing and processing of their personal information with/by NEF. NEF will process the personal information of related persons as stated under a contractual agreement or as required by any related legislation.

Examples of the personal information of the supplier or business partner where relevant may include (but are not limited to):

Financial information, including bank statements provided to the NEF;

Invoices issued by the supplier or business partner;

The contract/ legal agreement between the NEF and the supplier or business partner;

Other identifying information, which includes company registration numbers, VAT numbers, tax numbers and contact details; marital status and matrimonial property regime (e.g. married in community of property); nationality; age; language; date of birth; education; financial history; academic background and qualifications.

Identifying numbers (e.g. an account number, identity numbers or passport numbers); email address; physical address (e.g. residential address, work address or physical location);

Information about the location (e.g. geolocation or GPS location); telephone numbers; online and other unique identifiers; social media profile/s; biometric information (like fingerprints, facial recognition signature; race; gender; sex; criminal and credit history).

Example of Special personal information is personal information about the following: · criminal behavior, or any proceedings in respect of any offence allegedly committed by a data subject or the disposal of such proceedings; religious and philosophical beliefs; trade union membership; political beliefs; health, including physical or mental health, disability, and medical history; or biometric information (e.g., to verify identity).

NOTES

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if (applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
 - 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable.

Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25 "Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.

- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
- (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque
- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

**8. Inspection

- 8.1 All pre-bidding testing will be for the account of the bidder.
- 8.2 If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.
- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract supplies may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called

- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.

- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1 Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.

- 10.2 Documents to be submitted by the supplier are specified in SCC.

11. Insurance

- 11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.

12. Transportation

- 12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

13. Incidental services

- 13.1 The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:
- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
 - (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this

- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare parts

14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
- (b) in the event of termination of production of the spare parts:
 - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.

15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

21.5 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.

21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without canceling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default

23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
- (b) if the Supplier fails to perform any other obligation(s) under the contract; or
- (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the purchaser shall give the supplier a period of not more than fourteen (14) days to provide reasons why the envisaged restriction is necessary. If the supplier fails to respond within the stipulated fourteen (14) days the purchaser may regard the restriction as justified.

23.5 the intended penalty as not objected against and may impose it on the supplier.

23.6 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.

23.7 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:

- (i) the name and address of the supplier and / or person restricted by the purchaser;
- (ii) the date of commencement of the restriction
- (iii) the period of restriction; and
- (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.8 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

**24. Anti-dumping
and
countervailing
duties and rights**

24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him

25. Force Majeure

- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.
- 26. Termination for insolvency**
- 26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.
- 27. Settlement of Disputes**
- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.
- 27.5 Notwithstanding any reference to mediation and/or court proceedings herein,
- (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
- (b) the purchaser shall pay the supplier any monies due the supplier.
- 28. Limitation of liability**
- 28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;
- (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and

	(b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.
29. Governing language	29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
30. Applicable law	30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.
31. Notices	31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.
32. Taxes and duties	32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country. 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser. 32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.
33. National Industrial Participation Programme (NIP)	33.1 The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.
