1. DEPARTMENTAL AND PROJECT OVERVIEW

The Planning and Economic Development Department of the Ingquza Hill Local Municipality (IHLM) intends to appoint a suitable and experienced service provider to provide transportation support to local farmers in areas within the Municipality.

The project aims to assist farmers to transport their potatoes from Ugie to Flagstaff, thereby improving market access, reducing logistical constraints, and enhancing income generation for emerging and communal farmers.

The intervention forms part of the Municipality's Local Economic Development (LED) programme and is aligned with the IDP and SDBIP targets for agricultural support.

3. PURPOSE OF THE TERMS OF REFERENCE

The purpose of this Terms of Reference is to:

- Define the scope of work for transportation support services.
- Invite qualified service providers to submit proposals.
- Ensure transparent procurement and proper accountability.
- Facilitate timely transportation of Potatoes from Ugie by August 2026.

4. PROJECT OBJECTIVES

3.1 Overall Objectives

- Provide transportation services for potatoes within Ingquza Hill.
- Improve access to formal agricultural markets.
- Reduce post-harvest logistical challenges.
- Support income growth and sustainability of potatoes production in the Municipality.

- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
